After the amount billed has been approved, the Project Coordinator will review and let Subcontractor know if revisions are needed or to mail the original. Please do not mail original billings to our office until asked to do so.
- **SUBCONTRACTOR PROGRESS BILLING**
To be submitted for all progress billings. It is imperative that the Conditional Waiver and Release on Progress Payment at the bottom of the form be completed, dated and signed or your payment will not be processed.
- **SUBCONTRACTOR FINAL BILLING**
To be submitted for final billings, (one-time billings for subcontract amounts under \$1,000.00 and retention). It is imperative that the Conditional Waiver and Release on Final Payment at the bottom of the form be completed, dated and signed or your payment will not be processed.
- **SCHEDULE OF VALUES**
Subcontractor shall submit their Schedule of Values in an acceptable format prior to issuing their first pay application.
